During the operational inspection, our consultants focus on the building compliance itself, to ensure all safety measures are in place. This would include a building assessment followed by compiling fire escape plans. Cairnmead has a highly qualified operational team focused on this phase of a project.

Our operational consultant will conduct a building assessment to ensure that all the necessary requirements are met. A Full Operational Inspection of an existing building includes the Inspections of:

- Installed rational design for the fire installations, equipment, and evacuation control measures.
- The general use of the building.
- The general evaluation of the building structure.
- The general safety of the electrical installations.
- Building risk assessments.
- Emergency preparedness assessments.
- Operational Documentation Audit & Training.
- Evacuation Drill, Planning & Assessment.

The consultant will provide a site-specific report with all the required aspects that should be implemented to correct or improve the compliance of the building. With the first inspection of the building and along with the report provided, the building receives a rating of compliance. Along with the building inspections and operational requirements, Cairnmead also provides fire escape plans and diagrams. When the consultant has received the completed building plans, it is placed on our template with all the required SANS specifications:

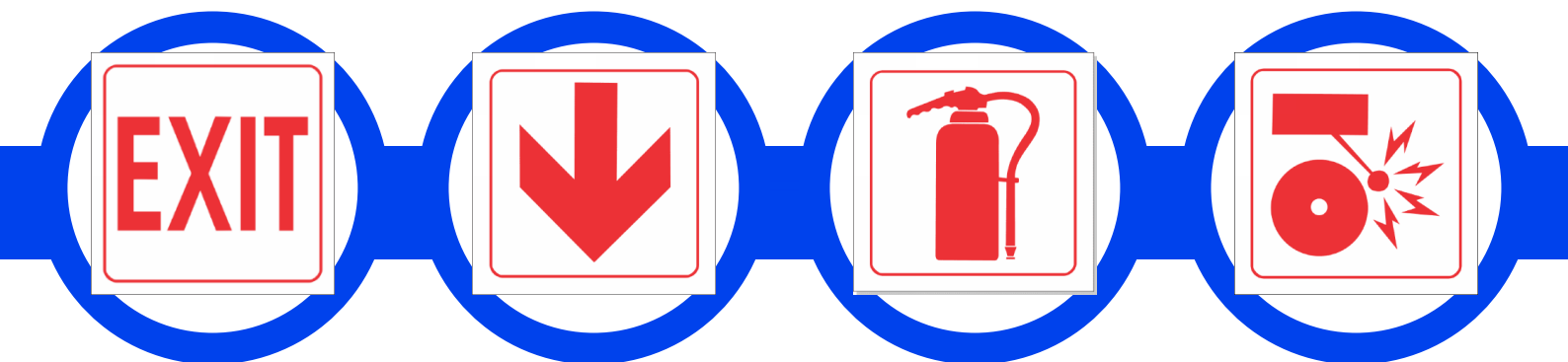

Our consultants include all escape routes as they should be identified on all plans and the location of fire equipment and alarms are to be identified. Emergency evacuation instructions should be present on the evacuation plans accompanied by the location of assembly points and refuge areas. Evacuation planning documentation includes expected people movement and any instructions given and the way they are to be given.

Once the initial building inspection and, if required, evacuation diagrams have been provided, the client is given a certain amount of time to implement the aspects mentioned within the report. It is the client's responsibility to apply the recommended changes; however, our consultants are available for assistance during this stage. The operational services Cairnmead provides are in accordance with the specific region bylaw requirements and procedures. We provide the client with an executive summary and conduct training on the report to ensure their understanding of the highlighted risks. Additionally, we offer an action plan as guidance to address these concerns.

The next stage would include the auditing stage, when the consultant would return to the site to conduct an audit and follow up on the previous report. The consultant will review the previous report and inspect the specific areas where a change had to be made. Once the audit is completed, the consultant will yet again provide a report summary of the site audit which will once again be sent to the client. This process will repeat until the entire building is compliant with the regulations.

RATING SYSTEM



As part of the Cairnmead Operational Consultants' assessment offering, we use a percentage grading system. This entails issuing a graining certificate if a certain percentage was achieved during the operational assessment.

The operational assessment has two focus points, one is the physical condition of the facility which entails conducting an onsite physical inspection and the second is the document verification process whereby the legal documentation required is reviewed to measure compliance. Both the focus points are listed on a scoring sheet and contribute to an overall compliance average for the facility.

The criteria being assessed are as per the audit content index document and are in line with the relevant legal requirements stated on the index.

When a platinum rating is achieved the certificate is issued with three stars, and if a percentage is achieved of 95% or more the facility will receive a platinum award (Trophy), each year for a period of three executive years if the platinum award is achieved with a percentage of at least 95% or more the facility will receive the Cairnmead Excellence Award (Trophy).

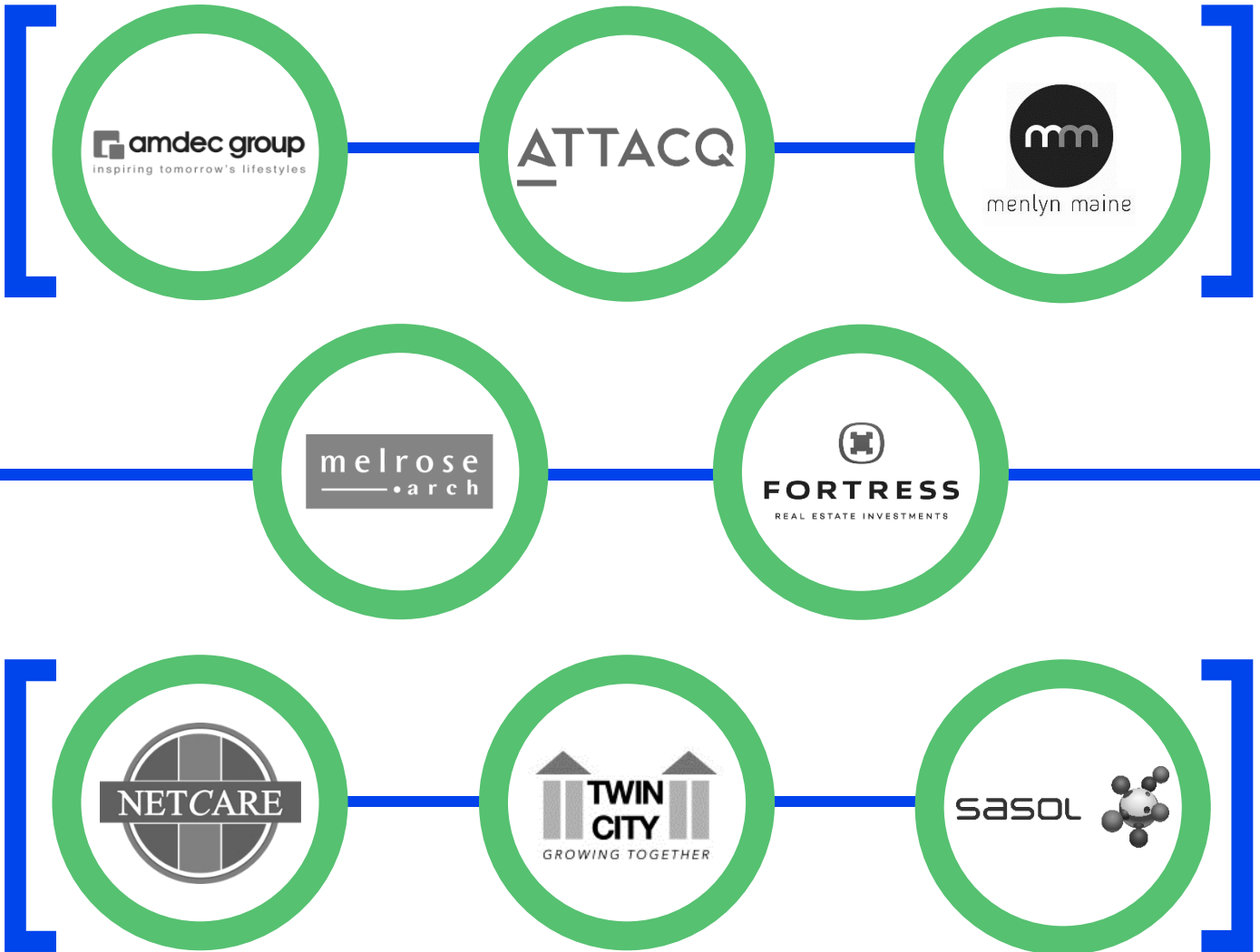
